### **NEW PROCEDURE & PRICING FOR COURSE MATERIAL**

From April 1, 2011 you are able to nominate whether you want to receive the printed course materials when you order a course, or not.

If you choose to receive the printed material, this will be delivered to your physical address and you will be charged the usual \$50.00 shipping fee.

If you do not wish to receive the printed material and prefer to download the PDF, you will then neither receive the printed material nor will you be charged the \$50 shipping fee.

When ordering your course with the printed text (full course) or without (electronic course), as you have done before, you will check the 'Course' box next to relevant course:

Accounting (core)

Course

At the bottom of the page there are two new options to specify which type of course is required:

I would like to receive a hard-copy course text - a shipping charge will apply.  
 I would NOT like to receive a hard-copy course text - no shipping charge will apply.

If you want the full course which includes the hard-copy material, check the first button. If you only want online access (electronic course) then select the second button. After that you proceed with the purchase as usual.
